## TIMESHARE AGREEMENT

This Timeshare Agreement is made by and among the following Licensees off three low-power FM stations serving the Cities of Alameda and Oakland, California.

- A. Alameda Community Radio —File # 20170821AAD; Facility ID 194947
- B. Alameda Unified School District File # 20170303ABI, Facility ID 195391
- C. Poor Magazine File # Numbers 20171013AHG, Facility ID 194853

The organizations named above have previously entered into a Timeshare Agreement and wish to amend and restate it as follows:

- 1. They each broadcast on Channel 241 in accordance with the schedule attached hereto as Exhibit A. The Parties agree that in accordance with FCC Regulations any changes in said broadcast schedule must be agreed to in advance by all three parties in writing and said document must be filed with the FCC prior to the date of any schedule change going into effect.
- 2. The Parties agree to broadcast programming for more than 10 hours weekly in accordance with the schedule shown below, *provided however* that on non-school days said requirement shall not apply to Alameda Unified School District.
- 3. Each applicant represents that it is a duly organized not for profit or educational organization existing and in good standing in the State of California.
- 4. The Parties acknowledge and agree that their purposes and goals in operating a low power FM station vary in significant respects, and that they do not wish the listening public to be confused or otherwise unclear as to the source of material being broadcast at any given time, or to attribute the programming of one of the Parties to the other. No Party to this Agreement will act at any time to (a) identify or mention the name of the other Party in any written material or on-air announcements or broadcast; (b) mention or identify the other Party on any website or any other information distributed on the Internet or otherwise or (c) hold itself out to the public as a partner associate or affiliate of the other Party.
- 5. To the extent that any information disclosed to any of the Parties hereto which is designated as confidential by disclosing Party shall be so treated any shall not be disclosed other than to the Parties' boards, attorneys or authorized representatives on a need to know basis.
- 6. The Parties acknowledge and agree that broadcasting beyond the designated hours is a serious violation of this Timeshare Agreement. If one Party violates the Timeshare Agreement, one of the other Parties will notify the Party in violation in writing. If the violations continue, the two other Parties have grounds to submit a formal complaint to the FCC.
