Note to the Public

This presentation was assembled using the <u>current state and county tiered framework</u> system for COVID-19 as related to school reopening policy.

We have been informed, and the <u>Governor's December 30 proposal</u> on school reopening suggests, that a potential or proposed change in the metrics related to school reopening policy are forthcoming.

While those new details are anticipated on January 8, at the time of this submission those details are not available.

It is then possible that information in this presentation will change prior to the January 12 Board Meeting should those changes in metrics and policy be made available ahead of time.

Current Public Health and School Reopening Status

- Case rates peaked in mid-December
- Have been slightly declining since then
- Impact of Christmas and New Year's still pending

Safe Schools for All: \$2 Billion to Incentivize School Reopening

- Applies to Transitional Kindergarten to Grade 6
- Pushes for TK-2 by 2/15 and TK-6 by 3/15
- Is silent on middle and high school
 - a. Small group classes, learning labs, and support centers intended for foster students, homeless students, and other students with greatest needs

INCREASES TESTING EXPECTATIONS SIGNIFICANTLY

- a. Districts in counties with less than 14 cases per 100K = students and staff tested every two weeks
- b. Higher incidence rate = everyone tested weekly



Safe Schools for All: \$2 Billion to Incentivize School Reopening

Testing

- Curative Labs major issues
- FDA concerns around false negatives
- Logistical and implementation challenges
- FDA concerned that type of test is appropriate for symptomatic patients but not for surveillance
- AUSD currently researching alternative test providers

Vaccine

- State in **Phase 1A**: health care workers and first responders
- **Phase 1B** includes educators more info in next few weeks
- Dependent on availability
- Phases may happen concurrently so educators could begin receiving prior to completion of 1A
- Current projection is early February

Working to Clarify New Information and Metrics

AUSD on Current County Tier Assignment System Widespread Our current More than 7.0 per 100k case rate =31.6 as of 1/8 **Substantial** 4.0-7.0 per 100k **Moderate** 1.0-3.9 per 100k **Minimal** less than 1.0 per 100k

Governor's December 30 proposal. Subject to legislative approval...

Counties MAY open if daily infection rate is lower than 28 per 100,000

Governor's plan goals:

- Feb 15 TK-2
- March 15 for TK-6

Note that the existing reopening metrics (figure 1) differ from new metrics and thresholds referenced in the Governor's December 30 proposal (figure 2). We hope to have clarity on changes by January 12.

Focus and Bandwidth Adjustments in Near Term

- Continued negotiations with labor
- Small group services and supports in early February
- Child care services and options
- Expanded summer session concepts
- Preparations and decisions for fall of 2021

Small Group Concepts (Goal is early February)

Groups of 6-8 students to begin.

Concept 1: Basic access to learning. Group is composed of students from variety of classes and supervised by a certificated or classified employee.

Concept 2: Students receive in-person support during asynchronous or independent time.

Schedules

Review of updated and proposed in-person schedule concepts on January 26.

Childcare and ASES Funded Programs Update

- Ruby Bridges, Love, and Paden will open childcare opportunities for students who received AIK support last fall. Those programs will begin in late January at those three sites.
- Ruby Bridges will have support from EDMO (current ASES provider).
- Love will have support from BACR (current ASES provider).
- Paden will have a combination of site staff and Alameda Arts support.
- AIK will continue to provide childcare at Franklin Elementary beginning in late January for focal students from Franklin, Otis, Edison, Earhart, Maya Lin, and Bay Farm.

Financial Support for Reopening: Federal

- Federal COVID Relief Package
 - Approximately \$3.2 Million for AUSD
 - In addition to uses approved under CARES Act., funds may be used for school facility repairs to reduce risk of virus transmission and maintenance and repair of HVAC Systems to improve air quality

Financial Support for Reopening: State

- State Safe Schools for All Funding
 - Provide in-person instruction to TK-2 students (as well as those needing intervention) by February 16
 - Expand in-person instruction to students all elementary grades by March 15
 - \$450/ADA to cover COVID-related expenditures
 - To qualify
 - Prepare COVID Safety Plan (CSP) per guidance to be released on January 8
 - May include student testing
 - Prepare safety plan for all employees following Cal OSHA & CDPH guidelines
 - Submit ratified collective bargaining agreements
 - Certify to ACOE that students who remain in distance learning have the necessary tools to participate in online education

What Remains Unclear

- How does the Safe Schools for All plan intersect with the ACPHD's orders?
- Will the Safe Schools for All plan override the current Blueprint for a Safer Economy tiers for re-opening?
- What happens if current case rates make it impossible for school districts to open?
- ACPHD is currently looking into these matters but has indicated they want their plans to align with the state's.
