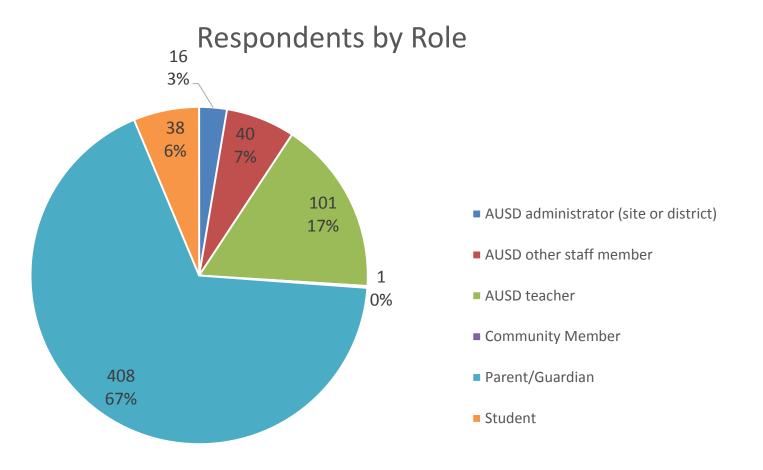

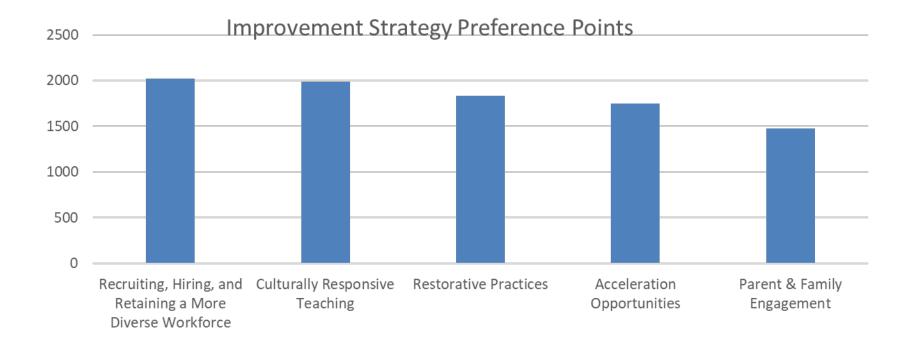

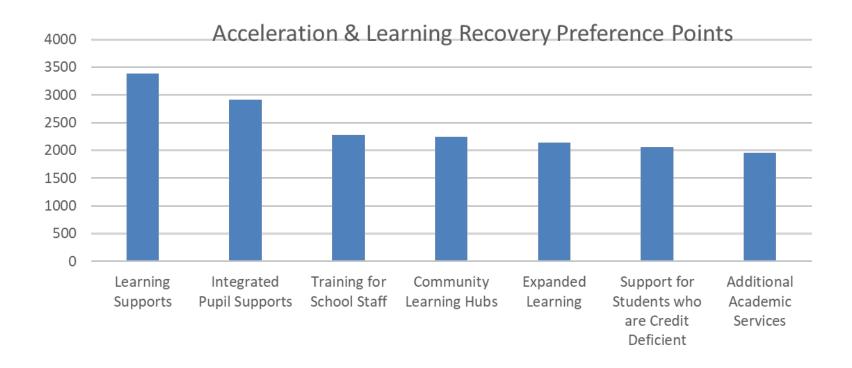


Engagement, cont...
