



## **Purpose of the CCEIS Plan**

The Comprehensive Coordinated Early Intervening Services (CCEIS) Plan is dedicated to early intervention and programmatic strategies that will decrease the over-identification of African American students qualifying for Special Education, specifically under the category of Other Health Impaired (OHI).

  - O Stakeholder Team- August 17, 2021, Sept. 7, 2021, September 29, 2021

# **Findings**

Findings from File Review, Focus Groups, Qualitative & Quantitative Data, supports Root Causes previously identified:

- 1. **Cultural dissonance, expectations and misconceptions:** Systemic racism and cultural dissonance results in a culture that lacks meaningful student relationships and culturally responsive practices which is evidenced by explicit and implicit biases, low expectations and misconceptions.
- 2. **Discipline policies and practices:** AUSD Staff's lack of equitable and consistent Implementation of Discipline Procedures and Practices
- 3. **Family and community partnerships:** AUSD has not built authentic partnerships with parents and families leading to strained relationships and distrust.



## Findings, cont...

4. Interventions and referrals: AUSD's lack of consistent, robust, first best instruction, and timely and effective referral for students who need interventions.

5. **Cultural dissonance and systemic racism:** AUSD's lack of creating hiring practices that attract and retain African American teachers and administrators.

## **Drafting the 2021 CCEIS Plan**

- There were over 10 Measurable Activities & Outcomes originally identified for the 2020 Plan. Decision was made to focus primarily on district infrastructure. Thus, the remaining Measurable Activities & Outcomes that were previously recommended were moved into the 2021 Measurable Activities and Outcomes. <u>Draft 2021 CCEIS Plan</u>
- Based on Stakeholder Parent Request: Conducted Additional Focus Group for OHI African-American parents, facilitated by Dr. Bacon on October 30, 2021 & November 1, 2021. Questionnaire sent to all 51 parents to assist in data collection to best understand their story and journey to OHI. All 51 parents/caregivers were called by phone. 7 responses to questionnaire, 3 individual parent interviews. Dr. Bacon's summary forthcoming.
- Several recommendations for the 2021 CCEIS Plan are a continuation of the 2020 Plan.

#### Summary of Recommended Activities and Outcomes for the 2021 CCEIS Plan

- 1. Increase Family Engagement for AA and Multi-Ethnic Families
- 2. Diversity, Equity, & Inclusion Community of Practice for Parents
- 3. Parent Engagement Education Workshops
- 4. Continue Scholar Program & Train on Dual Capacity Framework
- 5. MTSS-Culturally Responsive integrated into 504, COSTS Process, and Behavior Matrix
- 6. Professional Development & Ongoing Coaching for SST, COSTS, and Site Teams
