Brian,

See attached tabulations for this project. Sorry for the delay I got behind on these. I have put together tabulations so we can be on the same page here. This took some work on my end but wanted to be as fair as possible. I took the hard costs from the original proposal (mobilization, safety and Bonds) and then did a T&M style billing for the remaining of the work we completed on-site.

Couple of things I wanted to mention here:

• Excavation & Backfill – I assumed 20 LF x 24" Width x 40-48" Depth. Our team excavated a 4'x4' hole down to 48" in one location and another 4'x2' hole in another location,

along with the multiple locations we dug to try to expose and find the pipe on the other end in the outfall area. This is close to the numbers we input here and moved slower than what I expected just due to the on-site conditions we found and worked through.

- Piping Installation/Investigation We billed partial for this due to the numerous attempts at line locating which I put in this category. This work was completed by myself while I was on-site and I came out on a Saturday to take a look at as well and determine the path of the line.
- Concrete Installation The concrete portion of this quote only included materials and most the work was included in excavation. The \$1,765.40 is very low for the actual concrete work really in any situation. Our team had to work hours of overtime when we did patch back on one day as well. I highlighted the materials as well as work within the tabulations.

See attached tabulations and let me know if this is acceptable on your end. This ended up being very close to what we actually billed and indicative of the work we performed. I would ask that we stick with our original billing so that we do not lose time on processing as I know I delayed the process in getting this back to you. Thanks much and give me a call with any questions.

Hello Dan,

Last we discussed, you were going to take a second look at this pay app. Looking at the schedule of values your numbers looked a little higher for what the work that was actually accomplished. Additionally, you were pulling those guys to work multiple site at multiple times so they were not on-site a whole lot.

Items we would like adjustments are as follows:

Item 4 Excavation /Trenching and Back Fill – we certainly didn't complete 98% of the work we originally agreed upon. I would think it was closer to 50% for this item.

Item 5 Piping Installation / Investigation – We would think 30-40% is more appropriate considering that you install no pipe was installed during the course of this work.

Item 6 Concrete Installation - The original scope had you removing 15-20 lf of piping under concrete sidewalk I don't believe we came any where near that amount. We would like to see a reduction in the line Item as well.

Please rework and resubmit.
