PART I. GENERAL EXPECTATIONS

Love Elementary School agrees to implement the following legal requirements:

- During School Site Council meetings, the school will jointly develop with parents/guardians and distribute to parents/guardians a *School Family Involvement Policy* that the school and parents/guardians agree on.

- 8. Love Elementary School will provide parents/guardians of participating students, if requested by parents/guardians, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their students, and respond to any such suggestions as soon as practicably possible using the following:
 - a. Annual Title 1 Meeting
 - b. Parent Teacher Conferences
 - c. School Site Council Meetings
- 9. Love Elementary School will submit to the district any parent comments if the schoolwide plan under section (1114)(b)(2) is not satisfactory to parents/guardians following the District Uniform Complaint process.

PART III. SHARED RESPONSIBILITIES FOR HIGH STUDENT ACADEMIC ACHIEVEMENT

- 1.
