  - 3. Site English Learner Advisory Committee (Fall, Winter, Spring)
  - 4. Fall Family Conferences
  - 5. Student Study Team Meetings
- I. Wood Middle School will submit to the district any parent comments if the school wide plan under section (1114)(b)(2) is not satisfactory to parents/guardians of participating children, communicated by:
  - 1. Email/Parent Square communication
  - 2. District complaint procedure
  - 3. Meetings with site and district administration

## III. SHARED RESPONSIBILITIES FOR HIGH STUDENT ACADEMIC ACHIEVEMENT

- A. To ensure effective involvement of parents/guardian and to support a partnership among the school, parents/guardians, and the community to improve student academic achievements, Wood Middle School will offer the following:
  - 1. Individualized Intervention Plans
  - 2. After School Tutoring academic and enrichment activities
  - 3. Family Education Events and STEAM activities
