1. Design Survey

Conductfield survey, supporting office calculations, and drafting to create a design level topographic map with the extents generally depicted on the attached Exhibit "B". Topographic mapping within the limits shown will include:

- Building corners.
- Bleacher limits/corners.
- Fence and gates.
- Existing walkways with paired elevations at 15' O.C. for cross slope determination.
- Grade shots through boat ramp access road and other areas at 15' O.C. maximum.
- Hardscape features.
- Walls, including TW and BW elevations.
- Surface location of any utility features including invert elevations of sewer and storm drain structures where possible.
- Storm drain alignment, including invert elevations, to Central Avenue, if possible.

Mapping to be prepared at a scale of 1" = 10' with a contour interval of 1 foot, on the NAVD88 Datum, matching the previous topographic survey of Encincal High School Stadium conducted by Brelje and Race. Provide completed mapping in both pdf and AutoCAD format to client and design team for use in design.

2. Storm Drain Video Survey

Conduct video survey of approximately 600' of existing 24" storm drain along westerly property line. Observations will be presented on a USB and a NASSCO PACP database, as well as a written report. Footage and asset ID numbers will appear on screen for the duration of the survey.

3. **Fee**

Our fees for this work shall be billed monthly on a lump sum, percentage of completion basis, as follows:


Item 1: Design Survey:\$5,600Item 2: Storm Drain Video Survey:\$3,900Total Fee:\$9,500

Excluding fees for reproduction and plotting services which will be billed in addition to the engineering fees.

4. Assumptions and Limitations

- Survey will not include features (cleanouts, manholes, drop inlets, etc.) that are obscured by vegetation, debris, or otherwise hidden.
- Topographic survey does not include a boundary survey. Property lines will not be shown on the topographic map.
- Owner to provide any existing record utility plans available.
- Depths of utilities will be provided where possible to access through storm drain and/or sanitary sewer manholes, inlets, etc..
- The Engineers Services Rate Schedule is adjusted March 1 of each calendar year. Any work performed more than 4 months from the date of this proposal would be subject to adjustment based on the current fee schedule.
