# Process for Adoption of Instructional Materials

---

The Instructional Materials Adoption Process is guided by Board Policy 6161.1:

- Committee shall consist of a majority of teachers
- Opportunity for public viewing and comment
- Public hearing at BOE meeting
- Additional requirements define appropriate content, conflict of interest issues, and more

# A Balanced Approach

---

Staff are committed to a long-term plan that balances the needs for updated materials, capacity for implementation of new programs, and ongoing expenditures. To ensure that this balance is maintained, the following will be key elements of the adoption planning ongoing:

- Formation of a districtwide Curriculum Council to support planning (Council to consist of equal parts teachers and central staff/site administrators)
- Maintaining a teacher majority in all adoption committees
- Close collaboration with site principals in planning implementation

# Summary of K-Algebra 2 Math Adoption Process to Date

---

## 2014-15:

- Bridge materials from existing adoption (Math Expressions) provided to K-5
- Committees convened to pilot and review new materials
- Decision made to revisit adoption pending release of additional materials for review and to use bridge materials in 2015-16

## 2015-16:

- Bridge materials provided (Math Expressions/Eureka for K-5 and Glencoe for 6-8)
- Committees will review, pilot, and adopt materials at K – Algebra 2
