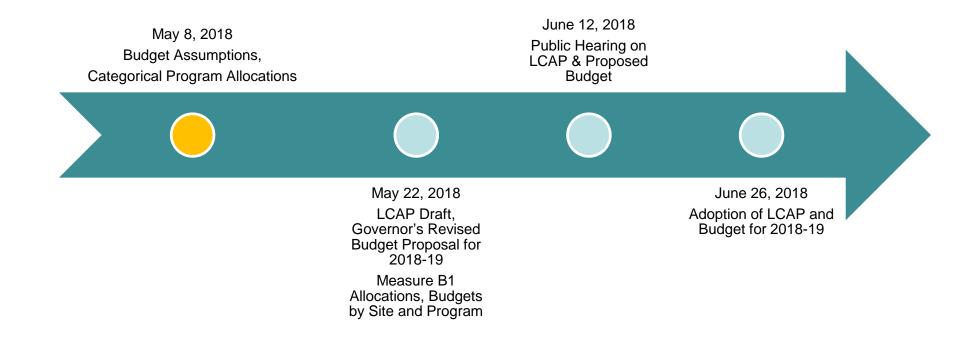
2018-2019 Budget & LCAP Adoption Process Background

- Per State Law AUSD's Board must adopt budget by June 30.
- Board must certify that the District's projected financial outlook for 2018-2019, 2019-2020, and 2020-2021 is one of the following:
 - Positive: WILL MEET the financial obligations for the current and two subsequent years
 - Qualified: MAY NOT MEET the financial obligations for the current and two subsequent fiscal years
 - Negative: WILL BE UNABLE TO MEET the financial obligations for the remainder of the current fiscal year and two subsequent fiscal years
- The approved budget and accompanying Multiyear Projections (MYP) will become the base document for all future financial decisions.

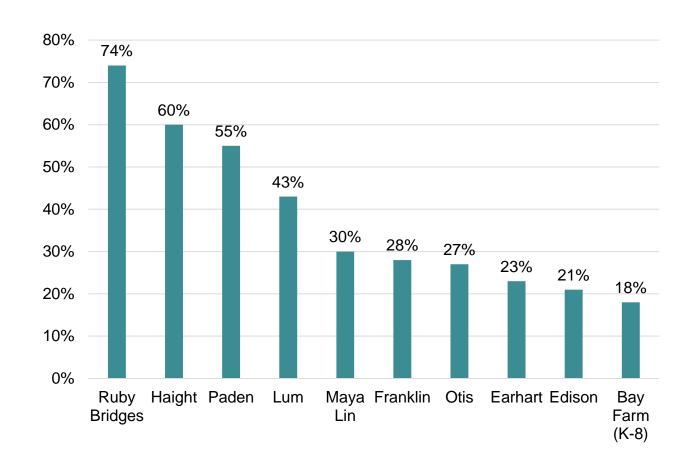

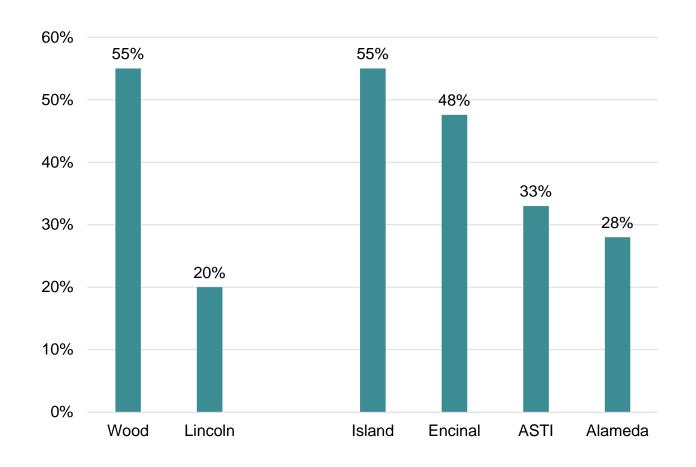
2018-2019 Budget & LCAP Adoption Process Unduplicated Student Percentage for 2017-18 – Elementary Schools



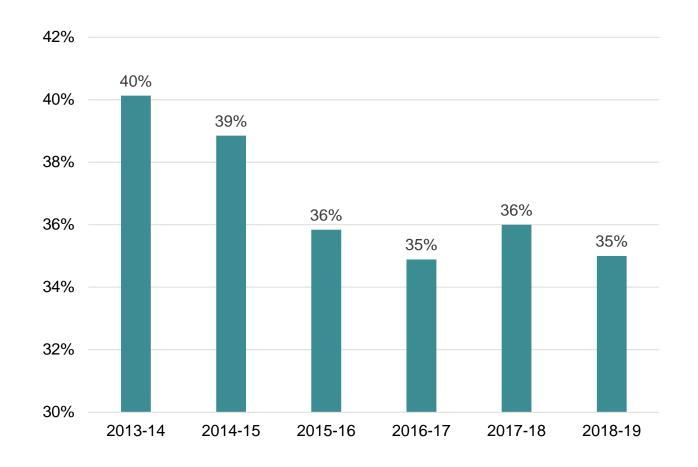

2018-2019 Budget & LCAP Adoption Process Categorical Allocations - Background

- Categorical programs are also known as "Restricted" programs.
- Federal and State categorical programs were created by the legislators to serve the special needs of students that are not covered by the general fund regular education programs.
- Each categorical program comes with its own program intent, rules, regulations, and exemplary practices.
- All categorical funds that schools receive and are allocated locally will additionally account for budgeting through the Single Plan for Student Achievement (SPSA).

2018-2019 Budget & LCAP Adoption Process Categorical Allocations – Title I

- Largest Federal program in California, aside from Special Education.
- AUSD qualifies for Title I based on the number of students who qualify for free or reduced meals.
- Students who receive services are those who show an academic need.
- AUSD must follow the Federal government's prescribed distribution formula and set aside funds for mandated services. Remaining funds are distributed among school sites.
- Funds can be used in a variety of ways as long as they provide supplemental support.
- AUSD estimates it will receive approximately \$1.02 million in Title I funding.

- Principals developed preliminary budgets in collaboration with School Site Councils (SSC).
- Principals reviewed the budgets with Educational Services, Human Resources, and Fiscal Services.
- SPSA's will be presented to the Board for approval on May 22, 2018.
- This is a work in progress, and the final SPSA allocation may be different from what you will see on next slides for Haight, Ruby Bridges, Paden, and Wood.

2018-2019 Budget & LCAP Adoption Process Categorical Allocations – Title II, Teacher Quality (TQ)

- The purpose of Title II, Teacher Quality, is to increase the academic achievement of all students by helping schools and districts to:
 - improve teacher and principal quality through professional development and other activities, including reduced class sizes; and
 - ensure all teachers are highly qualified.
- Districts first receive the amount they received for the Eisenhower Professional Development Grants and Federal Class-Size Reduction Programs. Remaining funds are allocated based 20% on child population (ages 5-17) and 80% on child poverty.



2018-2019 Budget & LCAP Adoption Process Categorical Allocations – Title II Teacher Quality (TQ)

- Can be used to recruit, hire, and retain highly qualified teachers and principals in academic subjects or schools where there are shortages (i.e., teachers for special needs students or math and science teachers).
- Funds are for all Alameda students and must be made available to private schools with Alameda students.
- AUSD estimates it will receive a total of \$206,413 in Title II, TQ, allocation.

2018-2019 Budget & LCAP Adoption Process Categorical Allocations – Title III, Immigrant Education

- An "immigrant student" is defined as an individual student who
 - is aged three through twenty-one;
 - was not born in any state (each of the 50 states, the District of Columbia, and the Commonwealth of Puerto Rico); and
 - has not been attending any one or more schools in the United States for more than three full school years.
- Funding is made available to eligible local educational agencies (LEA's) to provide supplementary programs and services to eligible immigrant students.
- The purpose of the grant is to assist immigrant students to acquire English and achieve grade-level and graduation standards.
- AUSD estimates it will receive a total of \$37,040 in Title III, Immigrant Education, allocation.

- The purpose of the Title III LEP Student Program is to ensure that all limited-English proficient (LEP) students, referred to as English learners in California, attain English proficiency, develop high levels of academic attainment in English, and meet the same challenging state academic standards as all other students.
- Funds must be used for the following supplementary services as part of the language instruction program for LEP students:
 - English language development instruction
 - Enhanced instruction in the core academic subjects
 - High-quality professional development for teachers and other staff
- AUSD estimates it will receive a total of \$159,625 in Title III, Limited English, allocation.

- The purpose of the program is to:
 - facilitate the enrollment, attendance, and success in school of homeless children and youth; and
 - ensure homeless children and youth have equal access to the same free, appropriate, public education as provided to all other students
- Funds must be used for supplementary services.
- AUSD is estimating it will receive a total of \$23,405 in Title X, McKinney Vento, allocation.
- AUSD will also allocate \$58.9K to McKinney Vento from the District's Title I and LCFF Supplemental Grant.

2018-2019 Budget & LCAP Adoption Process Categorical Allocations – Lottery (Restricted)

- Fifty percent (50%) of growth in lottery funds for education over the 1997-98 base year are allocated to LEAs (and community colleges) for the purchase of instructional materials.
- "Instructional materials" are defined in Education Code Section 60010 (h) as "all materials that are designed for use by pupils and their teachers as a learning resource and help pupils to acquire facts, skills, or opinions or to develop cognitive processes."
- AUSD estimates it will receive a total of \$454,320 in Restricted Lottery allocation.
 Indirect cost is not allowed. The unrestricted part of Lottery funds is part of Unrestricted General Fund.
- All funds will be spent on maintaining textbooks.



2018-2019 Budget & LCAP Adoption Process Categorical Allocations – After School Education & Safety

- Provides funding for academic and enrichment activities as constructive alternatives for kindergarten through grade nine students in before- and afterschool programs.
- Before- and after-school programs consist of two components:
 - An educational and literacy component to provide tutoring and/or homework assistance in one or more of the following subject areas: language arts, mathematics, history, social science, or science; and
 - An educational enrichment component, which may include but is not limited to recreation and prevention activities. Such activities might involve the visual and performing arts, music, physical activity, health promotion, and general recreation; career awareness and work preparation activities; community service-learning; and other youth development activities based on student needs and interests.
- AUSD estimates it will receive a total of \$631,564 in ASES allocation.

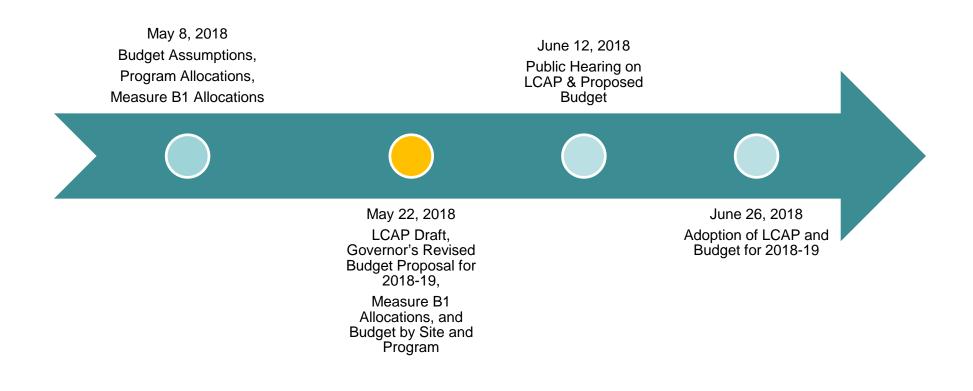
- Programmatic difficulty in trying to find new individuals to become mentors
- Dedicated TSA also provides support (on top of supporting induction candidates) to those on emergency permits (STSPs and PIPs) and internship credentials as required by established MOUs with universities and Commission on Teacher Credentialing regulations
- TSA also supports Career Technical Education and Adult School teachers in meeting credentialing requirements, different from induction requirements
- Teacher shortage will result in more individuals on emergency permits (STSPs and PIPs) that will require support, and currently there are no additional funds to provide such support
- Individuals currently on STSPs and PIPs enrolling into programs become intern eligible and will need additional support as well



2018-2019 Budget & LCAP Adoption Process Update on Implementation of Budget Realignment – Teacher Induction Prgm

- Only pathway for teachers to clear their preliminary credential
- Two year program, requiring mentors to meet with beginning teachers weekly for at least an hour
- Minimum 3 classroom observations during the school year
- Mentors must attend 5 days of professional development and mentor seminars
- Cost of 1 TSA versus 19 individual mentors is cost neutral, however the delivery model would be negatively impacted and require more work and a loss of staff and district efficiency
- 19 mentors = 1 TSA = \$63,786
- Staff estimate this to be cost neutral but an increase in work for those supervising
