- 2 All Bids shall cover the period of July 1, 2018 through June 30, 2019 with the option to renew for additional two (2) twelve (12) month periods by mutual written consent (Referenced Ed Code 17596).
- 3 Quantities listed here are estimates of the Districts need for the quotation period. These are estimates only and should not be construed to be a commitment to a minimum or a limitation to a maximum.
- This bid will be evaluated on the following factors: Price, competency, credibility, and compliance with all aspects of the specifications, exceptions that may be noted, and any other factors that may arise during the review process after bid opening.
- 5 Award shall be made based on the combined lowest responsive, responsible proposal based on pricing for all items listed. The Produce Bid will be awarded to one vendor. The Alameda Unified School District reserves the right to reject any or all Proposals, or any part thereof; to waive any informality or irregularity in the proposal; and to accept proposals that are in the best interest of the District. Award of the bid is contingent on the apparent successful bidder entering into an acceptable contract with the District.

- 7 Alameda USD supports California product. These items may receive preferential consideration.
- "Buy American" all items must originate in the United States unless not grown domestically or seasonally 8 available
- Payment terms are Net 60 Days. Each District shall be billed individually at the close of each calendar month, on an itemized invoice including delivery date, delivery location and units sold by item.
- 10 Pricing will not be increased without prior written authorization to Alameda USD Food and Nutrition Services Department. Proposed increases must be submitted 30 days in advance with documentation of corresponding consumer price index increase relative to this commodity. Note: Vendor must receive signed approval from lead agency, before price increases become effective.
- 11 If volume increases for any school site to a level that requires an additional delivery, the delivery schedule shall be modified to accommodate additional deliveries as needed. If the scheduled delivery date falls on a holiday, delivery must be made on a mutually agreed upon day and time. Upon award, the successful vendor will submit a District delivery schedule for approval. Proposed changes in the delivery schedule must be approved by the District in writing prior to the implementation of any such change. No deliveries will be accepted after 9:00am to all schools on scheduled school days.
- 12 Distributor will maintain local and state health codes for the facility and all delivery vehicles in accordance with the food safety guidelines of the governing local health codes. Vendors will submit with this guotation, a copy of the facility health permit or a recent health inspection report.
- 13 Non-Collusion Declaration: Each Proposer must return a fully executed Non-Collusion Declaration, as required by Public Contract Code section 7106, with the completed proposal. The Non-Collusion Declaration is included in this package.
- 14 Cost of Preparation: All costs for preparation of proposals shall be borne by the Proposer.
- 15 Insurance Requirements: All insurance must be issued by an Admitted Surety in the State of California. Each Proposer must return a fully executed Statement of Insurance Coverage with completed proposal. The Statement of Insurance Coverage is included in this package.
- 16 Liability Insurance: Proposer shall purchase and maintain such insurance as will protect Proposer and District from claims for damages because of bodily injury, including death, and from claims for damages to property which may arise out of or result from Proposer's operations under this Contract, whether such operations be by Proposer or anyone directly or indirectly employed by the Proposer. This insurance shall name District as an additional insured with an included additional insured endorsement required and shall be written for not less than Five Hundred Thousand Dollars (\$500,000.00) per person, One Million Dollars (\$1,000,000.00) per occurrence. Certificates of such insurance shall be filed with the District. The Certificates of Insurance will state that the contractual liability assumed is covered and shall provide that ten (10) days notice of cancellation or reduction in coverage shall be given District.

BUY AMERICAN CERTIFICATION

By the requirements of the Richard B. Russell National School Lunch Act's (NSLA) Buy American provision that school food authorities (SFAs) must follow these guidelines when purchasing food and food products for use in the Child Nutrition Programs. Section 104(d) of the William F. Goodling Child Nutrition Reauthorization Act of 1998 (Public Law 105-336) added a new provision, Section 12(n) of the NSLA (42 USC 1760(n)), requiring SFAs to purchase domestically grown and processed foods, to the maximum extent practicable.

Section 12(n) of the NSLA defines "domestic commodity or product" as one that is produced and processed in the United States substantially (greater than 51%) using agricultural commodities that are produced in the United States.

There are two situations which may warrant a waiver to permit purchases of foreign food products include: 1) the product is not produced or manufactured in the U.S. in sufficient and reasonable available quantities of a satisfactory quality; and 2) competitive bids reveal the costs of a U.S. product is significantly higher than the foreign product.
