**C. COMMUNICATIONS**

**1. Public Comments on Non-Agenda Items:**

*Asia Day (Teacher, Maya Lin)* highlighted educator compensation concerns and significant parking challenges at the school site.

*Tara Yudenfreund (Teacher, Maya Lin)* emphasized the financial and time burden caused by parking shortages and ticketing.

*Caephren McKenna (Teacher, Otis Elementary)* addressed compensation disparities, concerns about district fiscal priorities, and comparisons between superintendent and teacher raises.

*Corey Spells (Teacher, Maya Lin and Parent)* advocated for competitive salaries to retain educators and support student stability.

*Kevin Considine (Special Education Teacher)* described overwhelming SPED caseloads, paperwork burdens, and the impact on retention.

*Ron Parodi (Teacher, Encinal Jr. & Sr. High)* presented comparative financial data between Alameda USD and San Leandro USD, noting differences in compensation spending and reserves.

*Susan Marks (Parent)* expressed strong support for teachers, emphasizing the importance of retention and competitive compensation for student well being.

*Rodney Pierre Antoine (Teacher, Wood Middle School)* spoke about teacher turnover, the importance of PBIS, and the need for salaries that reflect educators' value and support retention.

**2. Written Correspondence:**

The Board received one email regarding General Business Item #3 – The swearing in of Board President Ryan LaLonde, and nine (9) emails regarding Consent Calendar item number 6 the Approval of Facilities Bond Measure I and Measure B Contracts specifically Project Addendum No. 2101.5 regarding the tennis courts at Alameda High School.

**3. Report from Employee Organizations:**

*Alameda Education Association: Judy Ganley, President and Veronica Huntsberry, Vice President:*

Ms. Ganley reported participating in the United Teachers of Richmond strike and expressed confidence in their progress. She affirmed respect for Superintendent Scuderi's leadership while emphasizing that educators, paraprofessionals, and custodians also deserve competitive compensation.

- Ms. Ganley presented historical data showing increases in the district's ending fund balance from 2019–2025.

- She compared Alameda's compensation spending to San Leandro Unified, noting that Alameda lags behind.
- She expressed confidence that the district and union would reach a resolution

Ms. Huntsberry expressed concerns about the district's reliance on contracted service providers, noting that contractors are costly and do not build long-term relationships with students. She urged the district to reduce contractor spending and increase salaries to attract and retain qualified educators, particularly for vulnerable student populations

4. Report from PTA Council:

5. Board Members' Report:

*Board President Gary Lym:* Board President Gary Lym reflected on a CSBA conference quote about students being "seen but not really seen." He shared an impactful encounter with a young autistic man who had experienced instability in foster care, homelessness, and lack of educational support. Board President Lym highlighted the importance of understanding the challenges faced by foster youth and expressed a commitment to learning more about the foster care system to better support students.

*Board Vice President Ryan LaLonde:* Board Vice President LaLonde welcomed new Board Member Carrie Hahnel, and he noted the value of attending the CSBA conference as a unified Board. Board Vice President LaLonde reported attending the first CSBA workshop focused on LGBTQ student support, expressing concern about limited representation of LGBTQ students and educators. He emphasized the importance of aligning district policies with local values and continuing advocacy for inclusive practices. Board President LaLonde noted productive conversations with neighboring districts, including San Leandro.

*Board Clerk Heather Little:* Board Clerk Heather Little reflected on recent conversations with AEA leadership, underscoring the importance of partnership and a shared understanding among all stakeholders. She reported that the CSBA conference highlighted significant statewide political shifts, including upcoming elections for governor, state superintendent, and legislative seats, and emphasized the critical need for statewide advocacy to increase public education funding, noting that many local conflicts are rooted in insufficient state investment. She also highlighted Alameda's reliance on parcel tax revenue and the likelihood of future renewal or expansion efforts, and encouraged continued unity among the board, district staff, and educators, emphasizing that the district's strength lies in collaboration and shared values.

*Board Member Carrie Hahnel:* Board Member Carrie Hahnel reported on CSBA sessions focused on funding inequities, particularly the disparities between basic aid districts and LCFF-funded districts like Alameda. She described Alameda as a "donut hole district," lacking both the high poverty levels needed to qualify for concentration grants and the excess local wealth of basic aid districts. She noted that statewide fiscal pressures — including rising operational costs, volatile revenue tied to the stock market, and political

uncertainty — impact all districts and cautioned that future state funding may increasingly take the form of one-time categorical programs rather than ongoing increases. She emphasized the importance of both local and statewide advocacy to secure sustainable funding for teacher compensation and student services.

*Board Member Jennifer Williams:* Board Member Jennifer Williams shared positive feedback from parents in the water polo community, recognizing the exceptional coaching and long-standing dedication of Encinal High School water polo coaches Kyle Baldi and Lani Molina. She highlighted their many years of service, their work with both JV and varsity teams for boys and girls, and their efforts to organize weekend tournaments that expand opportunities for student-athletes throughout the Bay Area, as well as the meaningful nature of Encinal High's Water Polo Senior Night.

She expressed appreciation for the hardworking AUSD staff and teachers who contribute to making the district a stable and valued community asset, and specifically thanked Sarah Noble for meeting regularly and Judy Ganley for maintaining open lines of communication as the district works collectively toward a new labor contract. She also acknowledged the contributions of educators at Alameda High School, expressed gratitude for the support and service of her fellow Board members, congratulated incoming Board President Ryan LaLonde, and she extended holiday well wishes to staff and colleagues.

6. Superintendent's Report:

Superintendent Scuderi thanked staff for attending and acknowledged the difficulty of ongoing negotiations. He emphasized that employees deserve more and that the district must continue examining its budget to identify opportunities for reprioritization. He reiterated that successful negotiations require outcomes that feel fair to all parties and committed to maintaining respect, creativity, and long-term responsibility throughout the process.

7. Student Board Member Reports:

*Roan Byrne Sarno (ASTI):* Updates included the annual ASTI Bowl, Fall Awards Night, multiple student fundraisers, and preparations for Peralta and ASTI finals.

*Ruth Woldesemayat (Alameda High):* Students participated in study halls, Winter Spirit Week, a door decorating competition, and a winter assembly. A winter fair was scheduled, and a canned food drive collected over 600 items.

*Donovan Smith (Encinal Jr. & Sr. High):* Leadership and band students visited a senior center for holiday activities. Donation drives continued, finals were scheduled for the coming week, and construction at Central and 3rd was nearing completion, with a ribbon-cutting planned for January 9, 2026.

## **E. GENERAL BUSINESS**

### **1. Approval of First Interim Budget and Approval of Resolution No. 2025-2026.26 Designating Certain General Funds as Committed Fund Balance**

Assistant Superintendent of Business Services, Shariq Khan, presented the First Interim Budget. The presentation covered updated revenue assumptions, multi-year projections, staffing trends, special education expenditures, and statewide fiscal conditions.

The district recommended a positive certification, indicating it can meet its financial obligations for the current and subsequent two years.

Key themes included:

- Enrollment increased by 50 students, generating approximately \$500,000 in additional revenue.
- The district anticipates a declining COLA, which may reduce revenue by roughly \$800,000 over three years.
- The district continues a planned seven-year drawdown of one-time funds used to support last year's compensation agreement.
- Staffing levels have increased significantly since pre-COVID years, particularly in special education.
- COVID era one-time funds temporarily increased the ending fund balance, but many associated programs will sunset unless new funding is identified.
- The district maintains reserves consistent with county averages and significantly healthier than districts currently in fiscal distress.

#### **Public Comment:**

*Ron Parodi (Teacher, Encinal Jr. & Sr. High)* Mr. Parodi raised concerns about large fluctuations in the district's projected ending fund balance between the September unaudited actuals and the First Interim Budget, noting that estimates for 2027–28 shifted from about \$6 million to as much as \$24 million. He stated that such changes create confusion for the public and employees and emphasized the need for greater transparency and clarity in financial projections.

Outgoing Board President Gary Lym reflected on his term by expressing gratitude to fellow trustees, district staff, and his family. He acknowledged the support he received while balancing board service with significant caregiving responsibilities, recognized individual board members and staff for their professionalism, compassion, and partnership, and emphasized the importance of teamwork, shared purpose, and a collective commitment to students and the community. He also offered personal thanks to his son for his emotional support during challenging times.

Board members and the Superintendent collectively offered remarks recognizing Outgoing President Gary Lym's leadership and service. They highlighted the demanding nature of the presidency and praised his humility, collaborative approach, and willingness to seek support when needed. They also commended his long-standing advocacy for youth, particularly in advancing college and career pathways, and noted the strong leadership culture he helped foster on the board.

The Board and Superintendent further acknowledged his steady commitment to students and staff, expressed appreciation for his partnership, and recognized his empathy and positive impact on students. They also expressed gratitude for his consistent focus on student well-being, fiscal responsibility, and equity.

Following recognition, the Board proceeded with officer transitions:

**ADJOURNMENT** – Board Member Jennifer Williams adjourned the meeting at 8:54pm in honor of former Board Member David Forbes, and Food and Nutrition Services staff member Eliodoro Garcia. Both members of the AUSD family passed away in November.

Former Board Member, David Forbes was educated in England and moved to Alameda in the late 1980's. He soon became involved in Alameda schools, serving as Edison PTA president and then as Alameda PTA Council President. While the PTA president at Edison, he started a partnership between Edison and the then Miller School to share PTA resources and fundraising events. This notion was new for the time and proved to be a mutually beneficial partnership for families, staff, and students alike. Mr. Forbes served on several local parcel tax committees, including chairing the successful Bond Measure in 2004. He was also heavily involved in a lawsuit several AUSD families filed to try to fix the way California schools are funded.

He was elected to the AUSD Board of Education from 2004-2008 and served as its president in 2007. He has been involved in the sailing industry for many years, and

led a nationally recognized sailing & powerboat school on San Francisco Bay. He has served on the Board of Girl's Inc. of the Island City and was a co-founder of the Alameda Community Sailing Center. He also recently served as the Board President of the Academy of Alameda.

Mr. Forbes was always a gentleman, and if you were lucky to know him well, he had a hilarious and very dry sense of humor. He is survived by his wife and children, and will be missed greatly by all who knew him.

Also last month, AUSD lost a dear friend and colleague, Mr. Eliodoro Garcia, who passed away after a courageous battle with cancer. For those who had the privilege of knowing and working with him, you know how much joy he brought to everyone around him. His infectious laugh, warm spirit, and unwavering "can-do" attitude made every day brighter.

For those who did not have the chance to know him, Mr. Garcia served as AUSD's Lead Cook at the Wood kitchen for the past 11 years, helping to provide meals to our students not only for Wood Middle School, but also for all of our elementary sites and several catered accounts. Mr. Garcia was one of the hardest-working individuals our district has ever had, and he will be deeply missed.

A moment of silence was held for David Forbes and Eliodoro Garcia.
